# E-safety

We have an **e-safety section** to the school website, there are plenty of useful guides and information for staff, parents, Governors and students. It would be great if you could find time to keep updated on any new information.

The safeguarding team will continue to send out the safeguarding update and e-safety parent update in case you miss any of the key messages.

As part of our drive to ensure the students stay safe at school or in "cyber space" it is important you know your responsibilities when handling personal and sensitive information.

#### **Data protection**

The school has a Personal Data policy. All staff should know and understand their statutory obligations under the Data Protection Act to ensure the safe keeping of personal data, minimising the risk of its loss or misuse. You must abide by the Data Protection Policy (found on the website and staff handbook) about the secure handling, transfer and disposal of data (passwords, encryption, and removable media).

We inform parents and carers about their rights and about the use of personal data through the Privacy Notice on the website and in Data Protection Policy.

#### **CEOP**

The school website displays the CEOP button where anyone can get advice, help or report an e-safety issue.

#### **Confidential email**

Any staff member can report confidential issues (including e safety) on the confidential email

### Health and wellbeing website for young people (27/02/15)

The 'Rise Above' website, launched today, offers help for young people on how to deal with personal and societal issues. Created by young people for young people, the 'Rise Above' website aims to build emotional resilience in individuals aged 11 to 16 by equipping them with the skills and knowledge they need to make informed decisions, and help deal with the pressures of growing up. It also encourages conversations about the key health and wellbeing issues that affect teens and young people.

HSE Case 348 - Children not allowed to have balloons (24/02/15)

Issue: Enquirer was told that they could not give out air-filled balloons to children after a library book event due to unspecified health and safety reasons. Instead they had to burst them and throw them away.

Panel opinion: What a lot of hot air! There are no health and safety regulations which stand in the way of children having fun with balloons.

The intention to introduce the measure was announced by the Prime Minister at the Girl Summit 2014, the first global summit to mobilise domestic and international efforts to end FGM within a generation

# 9. Reports - Bullying online

1in 7 seven children admit to bullying online (10/02/15)

One in seven (15%) children has bullied others online, according to a survey published by Action for Children today.

Nearly 60% of children responded that they bullied to fit in with a certain social group. The survey, which asked 2,000 8 to 17 year olds about their activity online, also revealed over 40% did so to prevent being targeted themselves.
